## **Annex 2 – Conditions consistent with the operating Schedule**

- 1. CCTV shall be installed and maintained at the premises and shall cover all areas open to members of the public in the dining area. All images shall be stored for a minimum of one month.
- 2. Access to the CCTV system shall be provided to Police Officers on request.
- 3. Signage shall be displayed at the premises, informing customers that CCTV is in operation.
- 4. A minimum of three Shift Managers shall be trained in the retrieval of CCTV footage.
- 5. A minimum of five staff members shall be on the premises whist open for licensable activities.
- 6. The premises shall operate a no open alcohol containers policy.
- 7. Customers shall only be permitted access to the ground floor dining area and disabled toilet during the hours for licensable activities.
- 8. All doors at the premises shall be fitted with a self-closing device.
- 9. All packaging supplied to customers at the premises shall display "Bin It".

- 10. Signs shall be prominently displayed at the exits from the premises reminding patrons there are residents living nearby and instructing them to respect the neighbours and to leave the premises promptly and quietly.
- 11. Signs shall be prominently displayed at the exits from the premises asking patrons to dispose of their waste in litter bins.
- 12. A responsible member of staff shall carry out proactive litter patrols outside the premises at least hourly throughout the premises' opening hours and specifically at the end of trading hours to ensure that there is no litter associated with the premises in the immediate vicinity and any such litter found shall be collected and returned to the premises for disposal with the premises' normal waste / refuse collection.
- 13. Any mechanical plant/equipment associated with the premises shall be correctly installed, operated, maintained, and regularly serviced, all in accordance with the manufacturer's instructions, to ensure that it is operating correctly and efficiently so as not to cause a nuisance to neighbours arising from noise.
- 14. Any ventilation and extraction systems and ducting associated with the premises shall be correctly installed, operated, maintained, and regularly serviced, all in accordance with the manufacturer's instructions, to ensure that they are operating correctly and efficiently so as not to cause a nuisance to neighbours arising from noise or odour.
- 15. Deliveries and collections (including refuse and/or recycling collections) associated with the premises shall be arranged between the hours of 06:00 to 22:00 hours only.
