Incident on Haldane Road on 20/09/2025

On Saturday 20th September 2025 at approx. 20:00hrs police were called to reports of anti-social behaviour in Haldane Road SW6 by a large group of youths who had damaged a bicycle and were throwing fireworks.

Police are currently making a number of enquiries to identify those responsible, and have increased patrols of the area. They will continue to do so over this coming weekend.

Police and the Hammersmith & Fulham Local Enforcement Team are also in the process of developing several proactive operations in the coming weeks, specifically targeting ASB in the area.

Dear Residents,

I wanted to update you following concerns raised at the community meeting on 23rd September and reports received on 20th September regarding anti-social behaviour in the Fulham area. These included large groups of young people setting off fireworks and causing risk to public safety.

To address this, I have authorised a Section 35 Dispersal Order under the Anti-social Behaviour, Crime and Policing Act 2014. This will run from 14:00 on Friday 26th September until 14:00 on Sunday 28th September and covers all areas within the boundaries of Lillie Road, Rylston Road, Dawes Road, Fulham Road, and West Brompton rail line bordering West Brompton Cemetery. I attach a map for your reference.

This authorisation gives my officers the power to direct individuals engaging in anti-social behaviour to leave the area and not return during this period. The decision meets the legal criteria and is designed to prevent further anti-social behaviour and keep our community safe.

You will see an increased policing presence in the area throughout the weekend, both to reassure the community and to deal swiftly with any issues.

I encourage you to continue to report any concerns or incidents to us via 101 (or 999 in an emergency) so police can respond accordingly. Your information helps us take action and keep Fulham safe for everyone.

Thank you for your continued support and for raising your concerns with us. Working together, we can tackle this behaviour and ensure our community remains a safe and welcoming place.

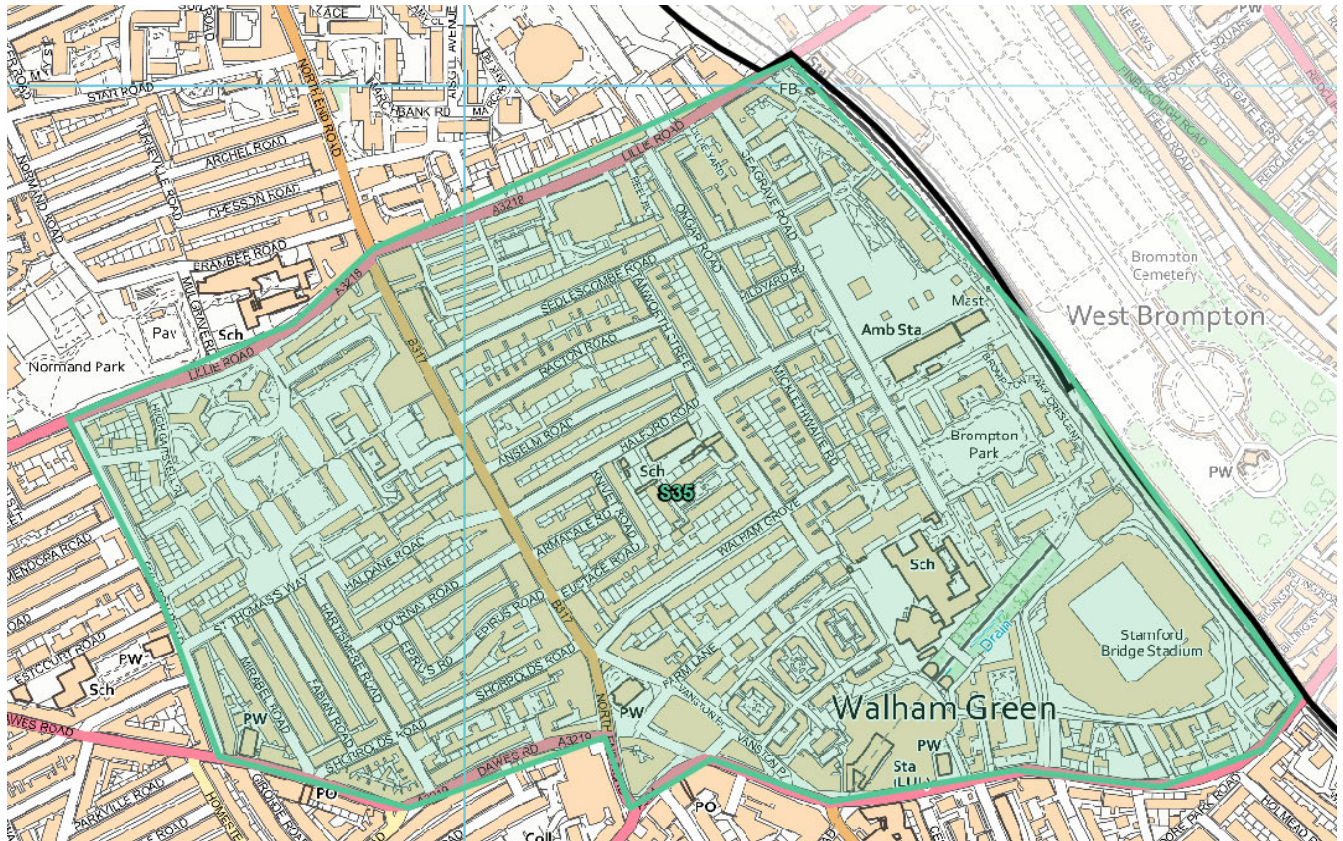

Update - Section 35 dispersal in Fulham on the 26th and 27th September 2025

Dear Residents

Over the weekend between the 26th September to the 28th September 2025, you may have seen an increased Police presence around the Walham Green and Lillie area of Fulham.

Fulham SNT police officers worked in partnership with Hammersmith & Fulham Law Enforcement Team following concerns from the local community regarding youth disorder the previous weekend. Police and the LET engaged with a large number of persons throughout the weekend, and where issues identified, these were robustly dealt with.

2 persons were stopped and searched for drug related offences and 1 person was stopped and searched for theft related offences. 1 youth was dispersed from the area using powers under the Dispersal Order put in place.

In an unrelated incident, officers patrolling the environs had cause to stop an adult male who was subsequently arrested and charged for drug related offences.
