This email and its related submitted evidence relates to the **North End Road street market neighbourhood.**

This area starts at Dawes Road and then Shorrolds Road on the left side and Walham Grove/Vanston Place on the right side of North End Road. Moving northward, it ends at the Lilly Road roundabout where intensely residential Clem Attlee Estate is not the left and the Peabody Estate on the right.

I have submitted the evidence via WeTransfer. As discussed, it relates directly to Supplemental A, pages 15-17, for the 14 Oct 2025 Licensing hearing.

This evidence also relates to the Met Police activities (public MetEngage website announcements) that Sarah Chambers (Chair of the Walham Green police/community Ward Panel) has submitted as a separate 6-page PDF Supplemental (Events leading up to the Sec 35 dispersal area in the two Wards that straddle North End Road specifically along each side of the street market area up to Lillie Road and further actions ongoing by the Police—planned through 5th Nov 2025).

A Section 35 dispersal area refers to powers granted to police under the <u>Anti-social Behaviour</u>, <u>Crime and Policing Act 2014</u> that allow officers to direct individuals to leave a public place for up to 48 hours if they are causing or likely to cause harassment, alarm, or distress to the public or contributing to crime and disorder. These dispersal orders are used as a preventative measure, enabling officers to remove individuals from an area to prevent such behaviour from occurring or continuing.

It is our hope that the H&F Licensing sub-committee will view and seriously consider this evidence in order to have a better idea of the challenges being faced by Leader Cowan, MP Coleman, Inspector Hayes/his teams, along with the residents directly on and off of the 18 roads and passageways of our North End Road street market neighbourhood.

For Licensing Committee members attending 14 Oct 2025 Licensing Hearing:

- 1. This evidence will give Committee Members a true sense of the ongoing frightening reality facing the ENTIRE North End Road street market neighbourhood.
- 2. Met Inspector Clive Hayes is identifying the approx 15 children involved (estimated 12 years-15 year olds)

- 3. This all relates to the SLP Policy 11, ..."licensing law is part of a holistic approach to the management of the night time economy."
- ..."impact in the direct locality and further afield."
- 4. It also relates to Policy 4 with regard to the cumulative impact of possibly one more licensed premise and therefore what would amount to a further increase in the number of licensed premises in this very 'densely residential area' of Fulham (Walham Green Ward), as well as in the 'almost entirely residential' Lillie Ward (Source: Lillie Ward: https://www.lbhf.gov.uk/councillors-and-democracy/about-hammersmith-fulham-council/ward-profiles/lillie-2024 Walham Green Ward:)
- 5. The level of crime and crime of asb and asb not defined as crime, is increasing within our neighbourhood, as evidenced by all above.
