Minister of Veterans and People opens Valour House

On the 30th October, Louise Sandher-Jones MP visited the King's Road Park development in Fulham to open one of two buildings acquired last year by The Stoll Foundation, which will provide a combined 128 new homes for vulnerable veterans and military family members.

The Minister was joined by veterans, trustees and staff from the Stoll Foundation, members of the Greater London Authority, officials from Hammersmith & Fulham Council and St William (part of the Berkeley Group) who are responsible for building the King's Road Park neighbourhood.

The site represents the biggest investment in social rent housing for veterans of the UK Armed Forces in

decades and will include new community facilities alongside the 128 apartments, including meeting spaces, therapy spaces, a disabled adapted gym, and new offices for The Stoll Foundation's front line staff.

Will Campbell-Wroe, Chief Executive for the Stoll Foundation, said "We were delighted to have the minister officially open Valour House, which will provide accommodation for veterans and their families for years to come. As the only specialist veteran housing provider that is registered with the Regulator of Social Housing we are proud to provide these high-quality homes at social rent in conjunction with the GLA and the Berkeley Group."

Minister of Veterans and People, Louise Sandher-Jones, said: "Every veteran deserves a safe, secure place to call home. That's not just a moral obligation – it's a promise this Government is determined to keep. Today marks another significant step towards delivering the Prime Minister's pledge to provide homes fit for our heroes across the United Kingdom.

"We're delivering real change through the Veterans Capital Housing Fund and it was fantastic to see firsthand how these homes are providing veterans and their families with the security and support they need."

Dean Summers, Divisional Managing Director of St James & St William, said: "We were honoured to join Veterans Minister Louise Sandher-Jones MP for the official opening of Valour House. It was also a huge pleasure to meet the veterans who have now made King's Road Park their home and I want to thank all our partners for supporting this project, including The Stoll Foundation, Hammersmith & Fulham Borough Council and the GLA.

"The ceremony is another fantastic milestone in the creation of King's Road Park. This regeneration project

is transforming a redundant 16-acre gasworks into a welcoming neighbourhood with a mix of private and affordable homes, a community park, shops, cafes and more than 400 permanent jobs.”

For the Committee:

According to my phone call with the developer's marketing people, 'The Windsor' building will house the Sainsbury's with entry/exit doors directly on the ground floor, fronting Sand's End Lane.

Directly across (not named) is the multi-storey 'Valour House' with 128 residences for War/former Active Duty veterans. Below that is a war memorial and an expansive green space, the war memorial park. Valour House is already occupied by veterans (the first residents in the development).

2)

LOCATION:

Sainsbury's will be in The Windsor building, ie directly opposite Valour House for veterans/Oswold Stoll Foundation. Below Valour House is a small war memorial park in green and below that a building clearly marked 'National Grid'.

The master plan includes 1,847 new homes (affordable and private).

3)

We discuss the vulnerability of many of these veterans in our original Representation. As well, we mention our concern for school children who will eventually live in this new, expansive completely residential 16-acre park-like neighbourhood.
