Page 31	Para 3.2; Add after 1 st sentence: <i>“One objection advised they represented the owners of Berghem Mews (listed as The Lawns 33 Thorpe Road, Peterborough PE3 6AB on page 28).</i>		
Page 36	Para. 5.2.10, line 14: after “the borough).” insert “The Mayor’s Affordable Housing and Viability SPD confirms “this will determine the maximum reasonable level of affordable housing up to 50 per cent based on the required tenure split.”		
Page 37	Para. 5.2.13, line 3: after “agreement” delete “, including an early stage viability review mechanism should the scheme fail to achieve substantial implementation within the specified timeframe, in accordance with London Plan Policy H5 (Part E)” and insert “An Early Review Mechanism is not required in this case, as the proposal already meets the London Plan’s maximum reasonable level of affordable housing of 50%.”
