3	<p>CONTRACTS</p> <p>Any contract which is made between you or the relevant person (or a body in which you or the relevant person has a beneficial interest) and Hammersmith and Fulham Council —</p> <p>(a) under which goods or services are to be provided or works are to be executed; and</p> <p>(b) which has not been fully discharged.</p>	n/a
4	<p>LAND</p> <p>Any beneficial interest you or the relevant person have in land within the area of Hammersmith and Fulham.</p>	Interest in a property in W12

5	<p>LICENCES</p> <p>Any licence (alone or jointly with others) you or the relevant person have to occupy land in the area of Hammersmith and Fulham for a month or longer.</p>	n/a
6	<p>CORPORATE TENANCIES</p> <p>Any tenancy where (to your knowledge)—</p> <p>(a) the landlord is Hammersmith and Fulham Council; and</p> <p>(b) the tenant is a body in which you or the relevant person have a beneficial interest.</p>	n/a
7	<p>SECURITIES</p> <p>Any beneficial interest you or the relevant person have in securities of a body where—</p> <p>(a) that body (to your knowledge) has a place of business or land in the area of Hammersmith and Fulham; and</p> <p>(b) either—</p> <p>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>	n/a
