4	<p>LAND</p> <p>Any beneficial interest you or the <b>relevant person</b> have in <b>land</b> within the area of Hammersmith and Fulham.</p>	None

5	<p>LICENCES</p> <p>Any licence (alone or jointly with others) you or the <b>relevant person</b> have to occupy <b>land</b> in the area of Hammersmith and Fulham for a month or longer.</p>	None
6	<p>CORPORATE TENANCIES</p> <p>Any tenancy where (to your knowledge)—</p> <p>(a) the landlord is Hammersmith and Fulham Council; and</p> <p>(b) the tenant is a body in which you or the <b>relevant person</b> have a beneficial interest.</p>	None
7	<p>SECURITIES</p> <p>Any beneficial interest you or the <b>relevant person</b> have in <b>securities</b> of a body where—</p> <p>(a) that body (to your knowledge) has a place of business or land in the area of Hammersmith and Fulham; and</p> <p>(b) either—</p> <p>(i) the total nominal value of the <b>securities</b> exceeds £25,000 or one hundredth of the total issued share capital of that body; or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or the <b>relevant person</b> has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>	None
